Privacy Collection Statement

This Privacy Collection Statement is provided by Newmark Capital Limited ACN 126 526 690 AFSL 319372 (**Newmark, we, our**).

If you register to receive news, updates or other information regarding the Jam Factory redevelopment project (**the Project**) or otherwise contact us regarding the Project, Newmark will collect personal information from you. The information collected may include your name, email address, phone number (including mobile phone number) or other contact details, together with details of the particular query submitted or information requested.

Newmark collects this personal information for the following purposes (**Collection Purposes**):

- to provide you with news, updates or other information regarding the Project;
- to invite you to information sessions or other similar events relating to the Project;
- to respond to your queries regarding the Project;
- to provide you with other information regarding the Project that we consider to be likely to be of interest to you; and
- to provide you with promotional and other material related to the Jam Factory complex.

The information that Newmark provides regarding the Project or the Jam Factory complex may include promotional, advertising or other direct marketing materials or messages in relation to the Project or the Jam Factory complex. If you do not wish to receive such promotional, advertising or other direct marketing materials or messages, you can opt out at any time.

Newmark may disclose your personal information to:

- our service providers who provide services to us in relation to the Collection Purposes, such as our electronic direct mail providers, event organisers or other relevant service providers; and
- the related companies of Newmark, where such disclosure is related to the Collection Purposes. The related companies of Newmark include Newmark Property Funds Management Pty Ltd and Newmark Asset Management Pty Ltd.

Some of the service providers to whom Newmark discloses your personal information may be based overseas (for example our electronic direct mail provider). It is not practicable to list every country in which such service providers are located, however it is likely that such countries may include the United States of America

If you do not provide the personal information requested by Newmark or provide incomplete or inaccurate information, Newmark may be limited in how Newmark can interact with you in relation to the Collection Purposes (in particular, Newmark may not be able to provide you with news, updates or other information regarding the Project or invite you to information sessions or other events regarding the Project).

The privacy policy of Newmark sets out further details of how Newmark will collect, store, manage, use and disclose personal information it collects from you.
